**DECLARATION OF BENEFICIAL USES AND OBJECTIVES OF WATER**

**FRESHWATER REACHES OF RAPID CREEK**

**DECLARATION OF OPEN AREAS ON ABORIGINAL LAND KATHERINE AND DALY RIVERS**

**SCHEDULE**

All that land near Ooloo in the Northern Territory of Australia being all those parts of the left bank of the Daly River lying between the most northern and the most eastern boundaries of Northern Territory Portion 4059 and that form the northeastern boundaries of the said Portion;

All that land near Claravale in the Northern Territory of Australia being all those parts of the left bank of the Daly Rivers lying between the most western and the most southern boundaries of Northern Territory Portion 3841 and that from the northeastern boundaries of the said Portion; and

All that land near the junction of the Flora, Daly and Katherine Rivers in the Northern Territory of Australia being all those parts of the beds and right banks of the Daly and Katherine Rivers within Northern Territory Portion 4321 that lie between the centreline of the said rivers to and including those parts of their right banks that form the eastern and northeastern boundaries of the said Portion.

**DECLARATION OF BENEFICIAL USES AND OBJECTIVES OF WATER**

**ELIZABETH AND HOWARD RIVERS REGION**

I, MINNA LYDIA RUTH SITZLER, the Acting Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, in pursuance of section 73(1) of the *Water Act*, declare that—

(a) in relation to the waterways known as the Elizabeth and Howard Rivers region and all the tributaries that enter those waterways and all lakes, lagoons, swamps and marshes situated in the catchment of those waterways—

(i) the beneficial uses are—

- (A) aquatic ecosystem protection; and
- (B) recreational water quality and aesthetics; and

(ii) the objectives that apply are as specified in Chapters 2 and 3 in the document entitled "Australian Water Quality Guidelines for Fresh and Marine Waters" ("the Water Quality Guidelines") published by the Australian and New Zealand Environment & Conservation Council and dated November 1992; and

(b) in relation to all groundwater within the boundary described in the Schedule—

(i) the beneficial uses are—

- (A) raw water for drinking
- (B) agricultural water use; and

(ii) the objectives that apply are as specified in Chapters 4 and 5 of the Water Quality Guidelines.
